It is the practice of David Thomas School of Music that each Client/Student is given an electronic ID and account to which monthly payments are billed. **Monthly Payment Amount: \$ _____.** All payments are to be made directly to the Company; **in no circumstances are payments to be given to Instructors.** Lack of payment, or lateness past 14 days will suspend instruction until payment is received. Your account will be automatically debited on a monthly basis for the amount of lessons specified until such time that we receive notice from you to cancel, subject to termination requirements.

Musical skills are built on the foundation of hard work and consistent monitoring from an Instructor. Since it is our desire that our Clients/Students gain the greatest possible benefit from their lessons, certain guidelines are suggested:

- Recommended practice time should be a half-hour 5-6 days per week.
- The Client/Student is responsible to promptly purchase all materials and music as needed for instruction; student must have use of musical instrument & lesson materials at time of instruction.

Lessons are to be taken continuously, as mutually agreed upon. If temporary schedule conflicts arise, make-up lessons are required. Those make-up days and times may be arranged through your Instructor directly. In the event of conflicts due to the following circumstances: accidents, family emergencies, or illness, we ask that you give your Instructor twenty four hour advance notice. If you do not contact your Instructor 24 hours before he/she arrives at your home to give the lesson, charges for lesson will be applied. Schedule changes involving more than four (4) weeks can be arranged with 30 days written advance notice to David Thomas School of Music.

If you wish to terminate lessons on a permanent basis, written notice is required. Termination requests received within ten (10) days of Original Client/Student Lesson Agreement date will be subject to minimum of one Monthly Payment Amount; termination requests received after 10 days of Original Client/Student Agreement date will be subject to payment of Monthly Payment Amount through Original Agreement expiration date, or as mutually agreed upon with David Thomas School of Music. Please contact our office with any questions, comments, or complaints about lessons or Instructors. While it is our hope to offer you a quality, long-term Instructor, David Thomas School of Music reserves the right to substitute Instructors should it become necessary.

Please be advised that David Thomas School of Music Instructors are Independent Contractors and are independently and solely liable for any property damage, injury, accident, or misconduct that occurs on premises of instruction. It is preferable that Parent have a Parent, Adult, or Legal Guardian on premises of lesson; however, Parent agrees, regardless of the attendance or absence of attendance by a Parent, Adult, or Legal Guardian during instruction, that Parent releases David Thomas Productions, Inc., David Thomas School of Music, and any future Subsidiaries of all liability and responsibility in any case of property damage, injury, accident, or misconduct.

Please note that all David Thomas School of Music Instructors have an Independent Contractor Agreement with David Thomas Productions, Inc. which prevents them from conducting lessons independently of David Thomas Productions, Inc. and/or David Thomas School of Music, with either current or previous David Thomas School of Music Clients/Students.
